    1. Article IV Section 1: change “not more than twenty one (21) members” to “not more than *twenty two (22)* members”
    2. Article IV Section 2: change “one (7) Junior Representative” to “*two (7) (8) Junior Representatives*”
    3. Article XI Section 3: Point Scoring, USHJA International Hunter Derby: Add “Points will be awarded as follows, 1<sup>st</sup> – 200, 2<sup>nd</sup> – 160, 3<sup>rd</sup> – 140, 4<sup>th</sup> – 120, 5<sup>th</sup> – 100, 6<sup>th</sup> – 80, 7<sup>th</sup> – 60, 8<sup>th</sup> – 40, 9<sup>th</sup> – 28, 10<sup>th</sup> – 20, 11<sup>th</sup> – 12, 12<sup>th</sup> – 8.”
    4. Article XI Section 3: Point Scoring, USHJA National Hunter Classic: Add “At ‘AA’ or ‘A’ rated competitions, points will be awarded as follows, 1<sup>st</sup> – 100, 2<sup>nd</sup> – 80, 3<sup>rd</sup> – 70, 4<sup>th</sup> – 60, 5<sup>th</sup> – 50, 6<sup>th</sup> – 40, 7<sup>th</sup> – 30, and 8<sup>th</sup> – 20. At ‘B’ or ‘C’ rated competitions, points will be awarded as follows: 1<sup>st</sup> – 75, 2<sup>nd</sup> – 65, 3<sup>rd</sup> – 55, 4<sup>th</sup> – 45, 5<sup>th</sup> – 35, 6<sup>th</sup> – 25, 7<sup>th</sup> – 20, 8<sup>th</sup> – 15.”
    5. Article XI Section 3: Point Scoring: change “if there are less than 3 in any age divided award...” to “*If there are fewer than 3 competitors in any year-end award, the award will be combined with the respective award section combined at competitions.*”
    6. Article XI Section 3: Point Scoring: Strike “The Pacific Northwest Equitation Classes, ~~USHJA Zone 9 Hunter Finals and the USHJA Zone 9 Jumper Finals~~ shall count for year end points...”
    7. Article XI Section 3: Point Scoring: Add “WSHJA recorded horses that are USEF/USHJA recorded horses and with owners residing in Zone 9 competing in the USHJA Zone 9 Finals and USHJA Zone 9 Championships will receive bonus points matching USHJA Zone bonus points.”
